- Restricted Stock Units ("RSUs") acquired by the reporting person on September 1, 2004 under the Scholastic Corporation Management Stock Purchase Plan in lieu of cash bonus; converted into shares of Common Stock on a one-to-one basis after expiration of the deferral period selected by the reporting person. RSU price was equal to 75% of the lowest closing price of the underlying Common Stock in the fiscal quarter ended August 31, 2004.
- Vests annually in three equal installments beginning on the first anniversary of the grant date.
